Summary:	The OneOhio Recovery Foundation, an Ohio 501(c)(3) nonprofit, is seeking bids for grant evaluation development services to support the development of clear metrics and outcomes collection that details the impact of the funds awarded.
Background:	<p>The One Ohio Recovery Foundation (oneohiofoundation.com) is a private, non-profit foundation created at the direction of Ohio's state and local leaders to distribute 55 percent of the funds our state will receive from the pharmaceutical industry due to its role in the national opioid epidemic. The Foundation will collaborate with local interests to support their opioid misuse treatment, recovery and prevention efforts and invest funds to support these efforts for Ohioans into the future.</p> <p>The Foundation is governed by a 29-member board, including 19 members selected by regional groups that partner with the Foundation in identifying local organizations to receive funds. Over the next several months, the Foundation will implement and award it's first round of regional grant awards.</p>

Work Plan:	Describe your company’s approach to delivering the services in the scope of work. Identify the staff working with the Foundation, include qualifications and brief work history with nonprofits. If other team members will be billing hours include their qualifications.
Assumptions:	Include any assumptions made in this proposal.
References:	Include a minimum of three nonprofit references.
Cost Proposal:	<p>Include a detailed cost proposal. Proposals may be based on deliverables, hourly rate, or a combination.</p> <ul style="list-style-type: none"> ▪ Deliverable cost must include detailed listing of services for the fixed amount. ▪ The hourly rate cost must include the estimated hours and hourly rate and detailed listing of services.
